She obtained successful determinations at the PTAB as both patent owner and petitioner. She also represented clients in both the U.S. District Court of Delaware and U.S. District Court of Massachusetts before securing a favorable eve of trial settlement ending the parties' multi-front battle.

Gina was a patent litigation associate at Wilson Sonsini Goodrich & Rosati where she represented Minerva Surgical and successfully defended against a preliminary injunction on patents related to medical devices after expedited discovery and hearing. She was also a patent litigation associate at Ropes & Gray where she represented Spansion Inc. in a large set of multi-patent cases related to flash memory technology, securing a settlement to the multi-forum dispute following a trial before the ITC.

Gina has also clerked for the Honorable Jimmie V. Reyna at the U.S. Court of Appeals for the Federal Circuit and for the Honorable Otis D. Wright II in the U.S. District Court for the Central District of California as part of the Patent Pilot Program.

Gina earned her J.D. from Georgetown University Law Center. During law school she interned at both the U.S. Patent and Trademark Office (USPTO) and U.S. Court of Appeals for the Federal Circuit.
